#### **CONSIDERATIONS FOR EVENTS AND GATHERINGS**

COVID-19 continues to be a danger to the health, safety, and welfare of the public, including vendors, employees, and volunteers. Additional measures are needed to minimize the spread of COVID-19 and protect the public while conducting County business. Exhibitors are “encouraged to wear face coverings” if social distancing is not possible. Exhibitors are encouraged to refrain from gatherings of more than 10 people in exhibit area.

#### **EXHIBITS, DISPLAYS, DEMO, MUSIC & SOUND**

Exhibitor decorations and displays, including patron “social distant” interactions, must appropriately reflect the theme of the event and should plan accordingly. All exhibits, demonstrations, and/or displays must be contained within the limits of an exhibitor’s assigned exhibit space. Sound and music is authorized-however, exhibitors agree to obtain necessary licenses to play or perform live or recorded music and agree to defend, indemnify and hold harmless Brevard County, Florida.

#### **FIRE & SAFETY**

Each exhibitor is charged with the knowledge of all laws, ordinances and regulations pertaining to health, fire prevention, and public safety while participating in the event. Exhibitors agree to be responsible and comply with national, state, county, and city regulations in the provision and maintenance of adequate safety devices at exhibits.

#### **SET UP TIME & CLOSING**

Event operates from 10am-3pm. Exhibitor setup will begin at 8:00am. Exhibitors must adhere to the posted times and be present for the duration of the event. Chili Cook-Off participant will supply their own 10x10 tents for individual serving with appropriate distancing for safety.

#### **POWER**

Electrical will be provided to exhibitors-exhibitors must provide their own extension cords.

#### **WEATHER**

Event may be cancelled due to severe inclement weather. In the event of cancelation, The Port St John Community Foundation will advise participants through the event’s Facebook and Instagram pages as well as our web site.
